Capitol Federal Financial, Inc. Announces True Blue® Capitol Dividend

TOPEKA, Kan., June 1, 2015 /PRNewswire/ -- Capitol Federal® Financial, Inc. (Nasdaq: CFFN) (the "Company") announced today that its Board of Directors has declared a True Blue Capitol dividend of \$0.25 per share on outstanding CFFN common stock. The cash dividend will be paid on June 26, 2015 to holders of record on June 12, 2015. This dividend will total approximately \$34.0 million. The True Blue Capitol dividend is the result of the Board of Directors' continued commitment to return value to our stockholders.

The Board of Directors of Capitol Federal® Savings Bank (the "Bank") also announced today that it has voted to make a capital distribution to CFFN in the amount of \$36.0 million, which will be paid prior to June 30, 2015. This additional capital distribution will allow CFFN to pay the \$0.25 per share True Blue Capitol dividend and continue with its stock-buyback plan.

For fiscal year 2015, it is the intent of the Board of Directors and management to continue with the payout of 100% of the Company's earnings to its stockholders. The payout is currently expected to be in the form of regular quarterly cash dividends and a special year-end cash dividend equal to fiscal year 2015 earnings in excess of the amount paid as regular quarterly cash dividends during fiscal year 2015. It is anticipated that the fiscal year 2015 special year-end cash dividend will be paid in December 2015. Dividend payments depend upon a number of factors including the Company's financial condition and results of operations, regulatory capital requirements, regulatory limitations on the Bank's ability to make capital distributions to the Company, and the amount of cash at the holding company.

Capitol Federal Financial, Inc. is the holding company for the Bank. The Bank has 47 branch locations in Kansas and Missouri, and is one of the largest residential lenders in the State of Kansas.
